

OASIS CHRISTIAN ACADEMY & FEARLESS CHURCH

Release of Claims / Media Release / Authorization for Emergency Care / Property Liability Waiver / Field Trips/ Transportation

1. Custody and Consent

Parent warrants and agrees that he/she (a) has legal custody or is the legal guardian of the Minor listed below; _____(b)(Student Name) understands the terms of this Release and Consent; and (c) has signed this document by his/her own free will. Parent acknowledges that Minor will, with Parent's permission, participate in certain activities ("School and Church Activities") conducted by or sponsored by Oasis Christian Academy, Inc. and Fearless Church, Inc., including their respective directors, officers, employees, volunteers, and agents (collectively referred to as "Academy/Church").

2. Media Release

Parent consents to the Academy/Church photographing and/or recording School and Church Activities and agrees that any photographs or recordings of the Minor taken by the Academy/Church are the property of the Academy/Church, to be used at their sole discretion for educational, promotional, or informational purposes. Neither Parent nor Minor shall be entitled to any compensation for such use.

3. Release of Claims & Liability Waiver

Parent, individually and on behalf of Minor, releases and agrees to hold the Academy/Church harmless from all liability for injury, illness, accident, or damage to Minor or Minor's personal property, whether resulting directly or indirectly from Minor's participation in School and Church Activities or from the Academy/Church's negligence. Parent, individually and on behalf of Minor, voluntarily assumes all risks and liabilities in connection with participation in School and Church Activities and agrees to indemnify and defend the Academy/Church against any claim, loss, or liability arising as a direct or indirect result of Minor's participation.

4. Personal Property

Parent understands that the Academy/Church is not responsible for the loss, theft, or damage of Minor's personal property brought onto school grounds, church grounds, or to School and Church Activities. Parent agrees that all personal belongings are the responsibility of the Parent and Minor.

5. Authorization for Emergency Care

In the event of Minor's injury or illness during any School or Church Activity, and in the event Parent cannot be reached, Parent authorizes the Academy/Church and its representatives to secure and consent to any medical, dental, or surgical treatment deemed necessary by a licensed medical professional. This includes, but is not limited to, the administration of X-rays, anesthetic, anesthesia, or emergency care. Parent assumes full financial responsibility for all medical services rendered and releases the Academy/Church from any duty of payment.

6. Mall Supervised Trips Authorization

Parent understands and agrees that due to the Academy/Church being located within a mall facility, students may from time to time participate in supervised trips within the mall, including but not limited to visits to the food court or walking the mall for recess and breaks. Parent grants permission for Minor to participate in such supervised trips and releases the Academy/Church from liability arising from these activities. Parent acknowledges that all such trips will be supervised by Academy/Church staff and conducted in a safe and orderly manner.

7. Field Trip and Off-Campus Activity Authorization

Parent grants permission for Minor to participate in field trips, outings, service projects, and other activities conducted or sponsored by the Academy/Church away from school or church grounds ("Off-Campus Activities"). Parent understands and acknowledges that Off-Campus Activities may involve travel and dangers and risks that

are inherent to such activities and that cannot be avoided or eliminated. Parent, individually and on behalf of Minor, expressly and voluntarily assumes all such inherent risks and releases and agrees to hold the Academy/Church harmless from all liability for injury, illness, accident, or damage to Minor arising directly or indirectly from Minor's participation in Off-Campus Activities, including from the Academy/Church's ordinary negligence, to the fullest extent permitted by law. *Parent understands that he/she has the right to refuse to grant this permission, and that the Academy/Church has the right to decline Minor's participation in the Off-Campus Activity if this permission is not granted.*

8. Transportation Authorization

Parent understands that transportation to and from Off-Campus Activities may be provided in private vehicles driven by Academy/Church staff, approved volunteers, or other parents/guardians, rather than by bus or commercial carrier. Parent grants permission for Minor to be transported in such vehicles and, individually and on behalf of Minor, releases and agrees to hold the Academy/Church and any authorized driver harmless from all liability arising directly or indirectly from such transportation, including from the driver's negligence.

Parent understands that the Academy/Church asks all drivers to hold a valid driver's license, maintain vehicle insurance meeting Florida's minimum requirements, and use seat belts and appropriate restraints for all passengers. *Parent may opt out of private-vehicle transportation and withdraw this consent at any time by notifying the Academy/Church in writing, in which case Parent agrees to arrange Minor's transportation to and from Off-Campus Activities.*
